TERMS OF SALE ALL SALES ARE FINAL - "AS IS" NO RETURNS

All vehicles, boats, motorcycles, etc. auctioned are sold "As is" and "Where Is" without warranty or guarantee of any kind. Neither the auctioneer nor the seller makes or implies warranties with respect to the auction items.

Auction bidders must register for the auction. The highest bidder must show his/her assigned bid card to the auctioneer upon vehicle being deemed sold.

Use of bid card means that the bidder has read and fully understands the terms of this auction and agrees to be bound thereby.

A \$100.00 cash deposit and state issued photo ID are required to receive a bid number. The cash deposit is refundable at the end of the auction for anyone who was not deemed highest bidder of any vehicles.

Permanent bid numbers may be obtained by keeping a \$100.00 cash deposit on file. Permanent bidders will be required to pick up their bid number on auction day at the cashier's office.

Payment is due in full at the time of the sale. If you have multiple winning bids during a single auction, you must pay for all of the vehicles - you may not choose to pay for some and not others. Any bidder who does not pay for the auction purchases by 11:30 a.m. will forfeit their deposit, and will be required to put down a \$200 cash deposit going forward. If a second instance of non-payment occurs with any bidder, they will be banned from future auctions. The condition remains that refund deposits that are not claimed at the time of the auction may be picked up in the form of a check Mon-Fri 9:00 a.m. - 3:00 p.m. (it is recommended that you call first 513-612-5980).

Acceptable methods of payment are Cash, Check, and Visa, MasterCard or Discover. Please note anyone writing a check which is then returned to Goodwill by their bank for reasons of insufficient funds, stop payment, account closed etc. will still be held liable for the purchase price and all applicable fees and subject to prosecution. Anyone paying by means of credit card that is subsequently declined will still be expected to pay by other means or forfeit their deposit.

Any person caught or suspected of tampering with vehicles belonging to Goodwill Auto Auction will be subject to prosecution or being banned from Goodwill property.

Titles for purchased vehicles will be put in the name of registrant. Titles may be put in the name of up to one additional family member per bid number, per auction. Additional family member must be present during auction to provide identification and sign paperwork.

If, at auction management's discretion on a case by case basis, it is determined that this practice is being abused, titles will be limited to being transferred to registrant's name only.

Licensed dealers are excluded from the above terms for titles being put in dealership name. Dealership owners may choose to put a title in their name, but will be subject to all taxes, fees and terms as applicable to individual sales.

Once a vehicle is paid for, the vehicle becomes the sole responsibility of the registered bidder. Goodwill assumes no responsibility for any damage or stolen parts. Any disputes on purchase price must be taken up with the Auctioneer directly following the auction.

Neither the Auctioneer nor Goodwill is responsible for personal injury or damage to property. Registered bidders are responsible for themselves as well as their employees, associates, or family members attending the auction. For safety reasons, children under the age of 15 must be accompanied by an adult at all times.

Titles and processing fees will be charged on all sales except dealers. Ohio residents pay Ohio sales tax based on the buyer's county of residence.

Goodwill makes no representation to the accuracy of the information the donor has provided to us on each vehicle. REMEMBER ALL VEHICLES ARE SOLD "AS IS".

If any dispute arises between two or more bidders, the decision of the auctioneer shall be final and absolute. The record of sale kept by the auctioneer and clerk will be taken as final in the event of any dispute. The auctioneer also has the right to open the bid between two or more bidders.

Goodwill and/or the Auctioneer reserve the right to withdraw from sale any vehicle, boat, etc. listed to sell.

The auctioneer is licensed and bonded in favor of the state of Ohio.
